

Privacy Statement

W.A.V. Tartlétoš greatly values the protection of your personal data. In this Privacy Statement we want to offer clear and transparent information about how we handle personal data.

We will do anything in our power to guarantee your privacy and therefore we will handle personal data very carefully. W.A.V. Tartlétoš will follow the laws and regulations in all cases, including the 'Algemene Verordening Gegevensbescherming'. As a result we will:

- Process your personal data in accordance with the goal for which the personal data is given, these purposes and the type of personal data are explained in this Privacy Statement;
- Limit the processing of your personal data to merely the data which is essential for the purposes for which they will be processed;
- Ask for your explicit permission if needed for the processing of your personal data;
- Have taken fitting technical and organisational measures to guarantee the safety of your personal data;
- Not pass on personal data to third parties, unless necessary for the implementation of the purposes for which the personal data is provided;
- Be aware of your rights regarding your personal data, want to point this out to you and respect it.

As W.A.V. Tartlétoš we are responsible for the processing of your personal data. If, after reading our Privacy Statement, or in a more general sense, you have questions about this or wish to contact us, you can do so via the contact details at the bottom of this document.

Personal data of members are processed by W.A.V. Tartlétos for the following purpose(s):

- Member administration;
- Contribution tax;
- Provision of information;
- Registration of participation in activities for Tartlétos invoice;
- Invitations to meetings;
- Sending the newsletter;
- Sending the WAK;
- Add to the private Facebook group;
- Add to the private Whatsapp group;
- Check sports rights.

The basis for this personal data is:

- Membership agreement (paper or form on the website)

For the above objective(s), W.A.V. Tartlétos requests the following personal data from you:

- First Name;
- Insertion;
- Last name;
- E-mail address;
- Telephone number;
- Date of birth;
- Birthplace;
- Address data;
- Wageningen University registration number;
- Sports card number SC de Bongerd;
- Bank account.

Your personal information processed by W.A.V. Tartlétos is stored for the above-mentioned purposes for the period:

- Up to 2 years after the end of membership;
- Tax information up to 7 years, due to tax laws and regulations.

Processing of results of members

W.A.V. Tartlétos can keep track of the results achieved by all members in competitions. We also publish the results of members on the website for club records, promotion of competitions and competition reports. For this we only use your name, date of the competition and the result itself.

Use of portrait

W.A.V. Tartlétos uses visual material taken at competitions, activities organized by W.A.V. Tartlétos or image material otherwise obtained for the promotion of W.A.V. Tartletos. Image material can be published on one of our social media channels (Whatsapp, Facebook or Instagram), in the newsletter, in the WAK, on www.tartletos.nl. In addition, visual material can be used as promotional material in brochures, posters and the like. Photos published on the aforementioned media can be deleted at the request of you as member.

Note: Visual material where a person is clearly in the picture is seen by the AVG as personal data. Permission for the use of this visual material is arranged via the registration form. Historisch archief

Distribution to third parties

We may provide the information that you provide to us to third parties if this is necessary for the purposes described above.

For example, we use a third party for:

- Taking care of newsletters (MailChimp) and the WAK (Editoo B.V);
- Aletiek.nu for registering for competitions and possibly NSK's;
- Atletiek Unie for registering as a competition member;
- Wened V.O.F. as the host of our website.

We never pass on personal data to other parties with whom we have not concluded a processing agreement. We naturally make the necessary arrangements with these parties (processors) to guarantee the security of your personal data. Furthermore, we will not provide the information provided by you to other parties, unless this is legally required and permitted. An example of this is that the police requests (personal) data from us in the context of an investigation. In such a case we must cooperate and are therefore obliged to provide this information. We can also share personal data with third parties if you give us written permission for this.

Retention period

W.A.V. Tartlétos does not store personal data for longer than necessary for the purpose for which it was provided or is required by law.

Security

We have taken appropriate technical and organizational measures to protect your personal data against unlawful processing, for example, we have taken the following measures;

- All persons who act on behalf of W.A.V. Tartlétos who can access your information, are bound by its confidentiality;
- We use a username and password policy on all our systems;
- We make backups of the personal data in order to be able to restore it in the event of physical or technical incidents;
- Documents with personal data is stored in a secure environment.

An exception is the paper registration forms, which are stored in a non-secure environment.

Rights concerning your data

You have the right to inspect, rectify or delete the personal data that we have received from you. You can also object to the processing of your personal data (or part of it) by us or by one of our processors. You also have the right to have the data provided by you transferred by us to yourself or by order of you directly to another party. We may ask you to provide proof of identity before we can respond to the aforementioned requests.

If we are allowed to process your personal data on the basis of your permission, you always have the right to withdraw this permission.

Complaints

If you have a complaint about the processing of your personal data, we ask you to contact us directly about this. If we cannot find a solution with you, we will of course find this very annoying. You always have the right to submit a complaint to the Autoriteit Persoonsgegevens, which is the supervisory authority in the field of privacy protection.
